Abdul Latif Jameel Water and Food Systems Lab Visiting Scholar Program

The Abdul Latif Jameel Water and Food Systems Lab (J-WAFS) was created to coordinate and promote water and food research at MIT, emphasizing the deployment of effective technologies, programs, and policies that will have a measurable and international impact as humankind adapts to a rapidly expanding and evolving population on a changing planet. J-WAFS sponsors efforts across disciplines that span on-campus research, policy studies, corporate and international partnerships, and technology development and commercialization. J-WAFS aims to improve the security, safety, and efficiency of the water and food supplies needed for a sustainable future—and a prosperous economy—for all people.

J-WAFS is welcoming visiting scholars to join this Institute-wide research program at MIT. Visiting scholars are welcome for a semester, academic year, or full 12-month year, and have all the benefits of institutional affiliation with MIT along with work space (which may be shared) within J-WAFS offices. No salary, stipend, lab space, computers, or housing are provided; this is intended for professors on sabbatical or other researchers who have their salaries covered by a home institution or research grant.

Eligibility

Academic visiting scholars should have a PhD and several years or more of research experience. (This is not intended to be a post-doc position.) Visiting scholars from other professions (e.g. policy, journalism) with a masters degree and sufficient professional experience may be considered. J-WAFS is interested in visiting scholars with interest and expertise across a range of areas related to the world’s water and food challenges. We are particularly interested in visiting scholars with areas of expertise that are complementary to MIT’s, such as agricultural field work, soil science, waste water management, agribusiness, nutrition, and policy. Visiting scholars are expected to have their own support, for instance a paid university sabbatical, or salary or research grant from a university, foundation, or government agency.

Applications are accepted on a rolling basis, however those received by May 1 for the fall semester and October 1 for the spring semester will receive first consideration. Note also that this opportunity is for visiting scholars with J-WAFS. Individuals interested in spending time in labs of PIs at MIT that J-WAFS supports would have to reach out directly to those professors.

Expectations and Requirements

Visiting scholars may conduct research, and are expected to interact with MIT faculty and students and to contribute to the food and water research community at MIT during their stay. Typical activities include offering research presentations or guest lectures in academic classes, conducting or participating in broader seminars and workshops, exploring future research collaborations, auditing classes, mentoring students, and other general scholarly interactions. Visitors receive MIT email addresses and have access to MIT libraries and MIT community events.

For International Scholars: J-WAFS visiting scholars must first apply to J-WAFS. J-WAFS will serve as liaison with the MIT International Scholars Office for accepted applicants. In order to apply for a visa, international visiting scholars will need to provide proof of the following:
